Here people can find information on services and voluntary support such as the Compassionate Companions befriending service run by Age Well East or hospice services. People can also follow links to the My Care Choices website or find information on what to do after someone dies.

The patient information centre contains links to national charities such as Macmillan, Marie Curie and Sue Ryder and also has information on medicines including anticipatory medication and syringe pumps, as well as links to sites with advice on CPR decisions.

Do not attempt cardiopulmonary resuscitation (DNACPR) decisions

Anticipatory decisions about CPR are best made in the wider context of advance care planning. Effective communication is essential to ensure that decisions about CPR are made well and understood clearly by all those involved. There should be clear, accurate, honest and timely communication with the patient and (unless the patient has requested confidentiality) those close to the patient, including provision of information and checking their understanding of what has been explained to them.

An audit this month within a local care home found 50% of DNACPR forms were incomplete, with a lack of documentation of discussion with the person and their family being the most common omission. The enhanced health in care homes teams are well placed to review any DNACPR forms that have been created during a hospital admission when a care home resident is discharged.
